7. took Members through the proposed KPI targets for 2021/22 as contained at the Appendix of the paper alongside the 2020/21 approved targets and actual figures for the first half of 2020/21.

## IV. <u>Update on Guiding Principles on Commercialisation</u> (BDC 19/2020)

9. Invited by the Chairman to introduce the paper, \_\_\_\_\_said that the proposed updates on the Guiding Principles on the Commercialisation of HKPC's Technologies (Guiding Principles) sought to reflect HKPC's commercialisation effort in deploying its patented technologies as background IP in client projects or services to clients, which in turn helped clients generate products or income.

16. Continuing with presentation, briefed Members on the financial forecast and business plans of the WFOEs in the next 3 years.

17. <u>Members</u> noted the progress report on the Mainland subsidiaries.

### VI. <u>2020/21 Mid-Term Report of Automotive Platforms and Application</u> <u>Systems R&D Centre</u> (BDC 21/2020)

18. <u>Members</u> received a presentation by on the performance and major R&D projects of Automotive Platforms and Application Systems R&D Centre (APAS) during the first half of 2020/21.

19. <u>Members</u> also noted that an additional funding of \$84.5 million was approved by the Legislative Council in June 2020 for the continued operation of APAS for a further 4 years of 2021/22 - 2024/25.

### VII. <u>Report on Projects for Government Funding Schemes (April –</u> <u>September 2020)</u> (BDC 22/2020)

20. <u>Members</u> noted the report by that between April and September 2020, 25 projects with HKPC's involvement were approved for \$51M under government funding schemes as follows:

- (a) Innovation and Technology Fund (ITF): 14 projects were approved for \$29.6M;
- (b) Trade and Industrial Organisation Support Fund (TSF): 10 projects were approved for \$20.2M; and
- (c) Fund for Better Living (FBL): 1 approved project for \$1.26M.

21. <u>Members</u> also noted HKPC's secretariat support to 9 government funding schemes during the report period, including:

- (a) BUD Fund;
- (b) Cleaner Production Partnership Programme (CPPP);
- (c) Retail Technology Adoption Assistance Scheme for Manpower Demand Management (ReTAAS);
- (d) Recycling Fund Enterprise Support Programme and Industry Support Programme;
- (e) Chinese Medicine Development Fund;
- (f) Patent Application Grant;
- (g) Local Mask Production Subsidy Scheme;
- (h) Distance Business Programme (D-Biz Programme); and
- (i) Pilot Subsidy Scheme for Third-party Logistics Service Providers (newly launched in October 2020).

### VIII. Final Performance Review of Completed ITF Projects (BDC 23/2020)

23. <u>Members</u> noted the final performance review of 6 completed ITF projects, as follows:

- (a) Development of the Nano Sol-gel Glass Materials and Process for 3D Glass Printing;
- (b)Development of High Efficiency RF Plasma System for High Concentrated Organic Wastewater Treatment;

- (c) To Develop Metal-Plastic Integrated Technology for Producing 3D Conductive and Multi-Functional Metallic Component on Plastic Part;
- (d) Study on Multiple Sensor Fusion Based Biomimetic Technology for Powered Exoskeleton;
- (e) Development of Enhanced Deep Learning System for Low-speed Autonomous Mobility; and
- (f) Metal Feedstock Foaming Technology for Realising Lightweight and High Performance Automotive Parts.

### IX. Any Other Business

#### (A) <u>Update on the Establishment of Industrial Artificial Intelligence and</u> <u>Robotics Centre (FLAIR)</u>

24. <u>Members</u> noted the update by about FLAIR commencing operation in October 2020 in the AIR@InnoHK research cluster at the Hong Kong Science Park to undertake AI and robotics solutions development projects for the manufacturing industry.

### (B) <u>Update on Collaboration with Tsinghua University</u>

25. informed Members of the collaboration between HKPC and Tsinghua University (Tsinghua).

#### (C) Latest Development of Inno Space

- 27. <u>Members</u> noted two new initiatives by Inno Space as presented by :
- (a) TechEd (i.e. Technology and Technical Education), a new label launched in October 2020 to raise awareness of Inno Space's top-notch STEM programmes along the main streams of coding education, maker education, aviation and engineering and creativity. To create awareness, the label was inaugurated by an experience day for school heads and STEM teachers, followed by a carnival for the public during 9-11 October 2020; and
- (b) a TechEd STEM Network joined by over 140 schools and universities, supporting organisations, education and corporate partners as a platform to bring together the supply and demand side of STEM stakeholders and other STEM partners. The purpose was to focus effort on nurturing STEM talents in Hong Kong through a wide range of STEM programmes along a structured learning pathway to meet the needs of young tech talents from kindergarten to university levels.

## (D) <u>FutureSkills</u>

28. <u>Members</u> noted the update by \_\_\_\_\_ on a new brand under the HKPC Academy, namely FutureSkills, to promote technology education in Industry 4.0, 5G technology, digitalisation and Internet of Things to upskill and equip the workforce for the new economy. Together with STEM programmes by Inno Space, HKPC's integrated learning programmes would address a spectrum of needs from kindergarten to university levels as well as cater to the demand for on-the-job training from industry practitioners.

# (F) <u>Activity Highlights</u>

- 30. <u>Members</u> noted the update by on two major events by HKPC:
- (a) "Foresight 2021" a large-scale virtual forum to be organised from 23 to 27 November 2020 with heavyweight business leaders and academics to share insights on the upcoming trends of enterprise transformation, technology innovation and new economic development in 2021. The event would be kicked off by a "Foresight Leader Forum", followed by a series of forums on the new economic drivers of Hong Kong which covered reindustrialisation, digital commerce, sustainability and green technology, future leader skills, and 5G and Internet of Things; and
- (b) "Cyber Security Fortnight" during 28 October 2020 and 13 November 2020, with webinars to promote a new cyber security scorecard service of HKPC and a competition, namely Hong Kong Cyber Security New Generation Capture the Flag Challenge 2020 to enhance the cyber security awareness of young people. With the participation of 37 secondary schools and 19 tertiary institutions, the competition was successfully concluded on 13 November 2020 with the award ceremony held with 200 participants.
