Plastics Technology Centre Industrial Club Membership Terms and Conditions

Plastics Technology Centre (the "Centre") operated by Hong Kong Productivity Council ("HKPC") has offered membership services to industry corporate enterprises. Applicant agrees to subscribe the membership of the Centre subject to the following terms and conditions:-

- 1. Membership package will generally include access to the Centre, complimentary technology consultation services, privileged price for attending workshops and seminars, free journal, member special discount and etc.
- 2. Member shall provide true, accurate, current and complete information about itself and its staff as required in the application form. If any information provided by it is found to be untrue, inaccurate or incomplete, HKPC has the right to suspend or terminate its membership and refuse any and all current or future use of any services by it and its staff.
- 3. Membership shall not be transferred or resold without the prior written consent of HKPC.
- 4. Member shall pay membership fee in the amount and manner as specified in its application form. Failure to make payment as committed will result in termination and revocation of its membership.
- 5. Member understands and agrees that HKPC, its officers, employees, contractors, consultants or agents shall not be liable to it for any direct, indirect, incidental, special, consequential or exemplary damages, including damages for loss of profits, goodwill, use, data or other intangible losses, resulting from use of the services provided by the Centre.
- 6. To the fullest extent permitted by the law, HKPC's maximum and aggregate liability in respect of any and all costs, expenses, losses and damages incurred or sustained by Member shall be expressly limited to and shall in no case exceed the amount of Membership Fee actually paid by Member to HKPC.
- 7. Member agrees to indemnify, defend and hold HKPC, its officers, employees, contractors, consultants or agents harmless from any cost, loss, expense, damage, claim or demand arising out of or related to its breach of any term and condition herein.
- 8. In the event of any dispute or difference arising as to the interpretation of the above terms and conditions or any matters contained therein, the decision of HKPC thereon shall be final and conclusive.
