


Five Component Sub-Indices of Overall Index


- 「招聘意向」及「投資意向」持續 上升,錄得50中性水平以上






- 行業指數趨於持平,較上季微升 2.0 至 44.9






- 行業指數較上季上升 3.4 至 45.5

- Most component sub-indices showed an upturn, except "Global Economy" which presented a drop of 3.3 to 40.4







- 訪問了817間本港中小企業的管理層
 Management of 817 SMEs were interviewed
