I. <u>Confirmation of Minutes</u> (P.C. 13/2022 Revised)

1. The Revised Draft Minutes of the 152nd Council Meeting held on 30 March 2023 had been circulated to Members. As there were no further requests for amendments, the Revised Draft Minutes were taken as read, confirmed and signed by the Chairman.

II. Matter Arising

(A) Paper Circulations Since Last Meeting

3. reported 2 paper circulations to Members since the last Council meeting held on 30 March 2023:

III. Annual Accounts for the Year 2022/23 (P.C. 18/2023)

- 5. Invited by the Chairman, took Members through the financial performance of HKPC, excluding Automotive Platforms and Application Systems R&D Centre (APAS), in 2022/23:
- (a) external income was \$717.3M, which was 19% above budget and exceeded 2021/22 by 17%;
- (c) total expenditure was 4.6% below budget;
- (d) an overall surplus of \$39M was achieved for 2022/23, which was better than budget by \$61.7M.
- 7. <u>Members</u> approved the annual accounts for 2022/23 which had been reviewed by the Audit Committee at its 62nd meeting held on 4 July 2023 and endorsed by the Finance Committee at its 78th meeting held on 11 July 2023 with no special comment.

- 14. <u>Members</u> approved the Annual Report on Key Performance Indicators (KPIs) for 2022/23.

IX. Three-year Strategic Plan of HKPC for 2024/25 to 2026/27 (P.C. 23/2023)

- 31. Invited by the Chairman, introduced to Members the paper on Three-year Strategic Plan for 2024/25-2026/27 (Strategic Plan). said that:
- (a) the Strategic Plan would continue to anchor on the strategic framework which comprised the HKPC Game Plan with 6 strategic directions in alignment with Government policy directions to promote new industrialisation, reinforce traditional advantages, develop emerging industries, groom local talents and support enterprises;
- (b) as a close partner of the Government in promoting new industrialisation, HKPC had provided staunch support to local companies in setting up smart production lines. Looking ahead, apart from continuing effort to attract leading Mainland and overseas companies to set up operations or expand business in Hong Kong, HKPC would work on enhancing the capability of Hong Kong SMEs for them to respond actively to supply chain evolvements and become suppliers of leading enterprises. This would support the optimisation and upgrading of industrial supply chains in GBA to propel the region's development;
- (c) HKPC would continue to devote effort to promote new industrialisation. A major marketing initiative was the TV mini-series on TVB in May 2023 which had attracted over 1 million viewers.
- (d) a New Industrialisation Development Centre was being set up to spearhead HKPC's related effort.

New Industrialisation Development Centre

34. <u>Members</u> then noted a presentation by on a New Industrialisation Development Centre (NI Centre) which was soft-launched on 7 July 2023 with the physical setup under renovation. said that HKPC had been proactively driving Industry 4.0 in Hong Kong for local enterprises to migrate towards smart manufacturing. As global supply chains placed more emphasis on digitalisation and sustainability, there was a need to enhance support to traditional and emerging industries. This would also drive the high value add development of Hong Kong's economy and promote the upgrading of the GBA supply chain.

After discussion, <u>Members</u> approved the Three-year Strategic Plan of HKPC for 2024/25 to 2026/27 which would be reflected in the Programme of Activities and Estimates (P&E) for 2024/25 to be submitted to the Council in November 2023.
