### (B) <u>New Industrialisation Initiatives</u>

33. <u>Members</u> noted the update by on the new industrialisation initiatives of HKPC, including:

- (a) GBA International Artificial Intelligence and Robotics Summit 2023 which took place in HKPC on 21 November 2023, bringing together 15 heavyweight speakers to share the latest trends, application scenarios and successful cases in AI and robotics to lead industry development. The event was attended by nearly 600 participants;
- (b) the findings of a "Hong Kong AI Industry Development Study" (the Study) which were released in November 2023. This study was the third consecutive annual study to promote new industrialisation, following the "Reindustrialisation Study Hong Kong" in November 2021 and the "Hong Kong Life and Health Industry Development Study" in November 2022. The Study had received wide media attention, reported by over 150 reports by the Hong Kong and Mainland media;
- (c) an experience centre on new industrialisation which was under renovation to showcase applied technology solutions in smart manufacturing, digitalisation and sustainability to acquaint the public with new industrialisation and 新質生產力. Members would be invited to the Centre's official opening which was planned for early 2024;
- (d) Hong Kong Got Industries: Strategic Alliance Showcase (「香港有工業」 重要夥伴起動大會) to be held on 8 January 2024 in celebration of the achievements of HKPC's industry partners as a testament to the robust industrial environment in Hong Kong; and
- (e) a 2-minute TV programme, comprising 5 episodes, to be aired on 4 Cantonese and English TVB channels (Jade, J2, Pearl and News & Finance) over 5 weeks from 18 December 2023 to enhance the brand positioning of HKPC as a key facilitator to promote new industrialisation, new productivity and Belt and Road.

34. referred to the theme of "Hong Kong Got Industries" (「香港有工業」) which would be adopted in more coming events to drive home the message that industrial development presented growth prospects to Hong Kong, creating job and personal development opportunities for citizens. It was hoped to contribute to the effort to inject a positive vibe to the community and cultivate a stronger sense of belonging and fulfilment among the local population.

35. noted that these initiatives by HKPC were in line with The Chief Executive's 2023 Policy Address and along the direction of the national development plan outlined in the 20<sup>th</sup> National Congress report. said that HKPC had an important role in promoting innovation and technology and new industrialisation to realise the vision for Hong Kong. With the impending appointment of Commissioner for Industry (Innovation and Technology) by the Government, looked forward to HKPC working closely in tandem with the Government to enhance the innovation and technology ecosystem for the benefit of Hong Kong.
